Staff Report

1. 547 Neck Rd. Ch. 61A update

Mr. Keating provided members of the Board with some background information on what Chapter 61A is. He was hoping this would lead to a better understanding of the use, non-use and the version of use.

2. Master Plan Process

a. Community Forum Update

The Town had received 34 Surveys to date. Mr. Keating told the board that they were forwarding the award contract and the letter to the consultant as soon as he got the appropriate signatures. Member Frantz voiced disappointment in the survey turnout. A discussion took place of the best way to get more surveys completed. Member Dickinson suggested contacting the elementary/middle school for the best way to get the information to the parents. Member Brown wanted to make sure that we promoted the fact that we were a Mother Town, that is very historic.

3. Wayfinding Program – Stakeholder Interviews

A general overview of the findings of the Stakeholders Interviews was given by Mr. Keating. There would be a follow-up meeting this Wednesday at 10 a.m.

4. Solar Battery Decommissioning Report & Bond Agreements

As soon as Mr. Keating receives the Decommissioning Report, he will get a bid from BSC. The inflation factor was also discussed between the Board and the Director.

5. Hawthorne Lane Update

Mr. Keating told the members that he and members of the Conservation Commission had walked the property on Hawthorne Lane. The Chair and Mr. Keating discussed the subdivision expiration date.

6. 13 Neck Rd. 40 B Project

Mr. Keating had included in the packet the peer review and responses. He talked about the different ways the various towns had taken care of similar issues. A general discussion took place concerning sewer credits and whether this would be added to the agenda for the 25th of March.

7. Update on Hiring Process of Conservation Agent

A second round of interviews took place last week. They had one applicant that was very strong in both Conservation and Planning. If the applicant was accepted and took the offer, he would be on board sometime in the first week of April. The Chair asked if anyone on the Board had any comments.
